STATEMENT

To complete our application for photography, film/video shooting permit, we hereby declare that:

1. We shall obey all the rules and regulations issued by the Government of the Republic of Indonesia, whether they are the ones issued by the Central Government or by the Local Government.
2. We are aware of the obligation to report, upon arrival, to the Department of Foreign Affairs cq the Directorate of Foreign Affairs Information for a general briefing on film/video shooting procedures in Indonesia.
3. We shall not make any shooting or recording of any object/location other than what are indicated in the shooting permit based on the script/synopsis forwarded by us.
4. We shall neither make any shooting/recording of prohibited objects and restricted locations nor of any other objects/locations which might create a harmful impression to the image of the government and the nation.
5. We shall be responsible and pay full compensation for the expense that might be occurring from filming/recording prohibited objects and restricted areas.
6. We agree to bear all the expenses of a Department's official appointed to accompany the team during filming/recording, i.e. board and lodging, transportation cost, daily allowance and any other additional expenses that might occur during filming/recording.
7. We are to re-export all equipment after completion of our activities;
8. We are to submit one release copy of the film/video to the Department of Foreign Affairs cq Directorate of Foreign Affairs Information through the Indonesian Embassy, and we have no objection whatsoever to its being used by the Indonesian government for non-commercial purposes based on national interest in Indonesia as well as abroad.
